Recognition of Territory

Bishop Jason Zinko (MNO Synod Co-Chaplain) recited the Recognition of Territory.

Opening Worship

Meeting co-chaplains Rev. Chris Bishopp, Sarah Harrington, and Bishop Jason Zinko led the Opening Worship.

Business Session One:

Vice-Chair Bruce Cook called the meeting to order.

Recognition of Territory / Welcome

Vice-Chair Bruce Cook cited the Land Acknowledgement at the beginning of the meeting.

Today, we meet on Treaty 1 territory. On August 3rd, 1971, Treaty 1 was made between the Anishinaabe and Muskegon Cree peoples and the Crown. The seven First Nations that are represented by Treaty One Nationare: Peguis First Nation, Sagkeeng First Nation, Brokenhead Ojibway Nation, Roseau River Anishinaabe First Nation, Long Plain First Nation, Sandy Bay Ojibway First Nation and Swan Lake First Nation. This land is part of who they are — their blood, their past, their current and their future.

Land acknowledgements are not meant to shame people, but to encourage each of us to live into reconciliation and the calls to action and to break down the barriers that colonialism has created for generations. How do I, how do we break down these barriers? If we have a question, do some research; watch indigenous movies and documentaries; learn more about indigenous art and artists; visit a local indigenous friendship centre; participate in Orange Shirt Day; go to a powwow; invite elders to share their knowledge. We strive for respectful partnerships with all the first peoples of this province and this country as we search for paths to healing and true reconciliation and honour this beautiful land together. We acknowledge the harms of the past, we are committed to improving relationships in the spirit of reconciliation, and we appreciate the opportunity to meet and live and learn on these traditional lands in mutual respect.

Bruce welcomed our online meeting participant, Bishop Kathy Martin, BC Synod; Assistant to the Bishop for Worship, The Very Rev. Peter Wall (first time in NCC); and our guest from the Evangelical Lutheran Church in America (ELCA) Rev. Tara Lynn.

The ELCIC's National Church Council (NCC) met September 7-9, 2023. This was NCC's first time meeting at the ELCIC's new office space located at 400-185 Carlton Street, Winnipeg.

Bishop Jason Zinko, Sarah Harrington and Rev. Chris Bishopp, from the MNO Synod, led worship for the meeting.

Anti-Racism Training

On Friday morning, NCC members participated in anti-racism training led by Carmen Ramirez, Assistant to the Bishop for Diversity, Equity and Inclusion, and Brian Mitchell-Walker, certified life-coach and executive coach at Be Mindfully Well and Deep Living Institute. This was the second anti-racism training session for NCC members. The session focused on knowledge, terminology, the *Doctrine of Discovery*, markers of white supremacy culture and included videos on white privilege.

NCC Welcomes Special Guest

NCC welcomed Rev. Tara Lynn from the Evangelical Lutheran Church in America (ELCA). Rev. Lynn is a member of the ELCA's National Church Council. As chair of the Faith, Society and Innovation Committee she serves on the executive team for the ELCA. She spoke of some of the "similar challenges and similar joys" that the ELCIC and ELCA share. The ELCA has embarked on a "future church initiative," as they spend time considering what the future of the church will look like, including future structure, future shape and purpose. They are also working on "strategy towards authentic diversity."



Office Dedication

As this was the first meeting of NCC at the new shared office space for the ELCIC and Canadian Lutheran World Relief (CLWR), a dedication of the new space was held on Friday afternoon with ELCIC and CLWR staff also present.

2023 ELCIC Special Convention

A significant amount of agenda time for NCC was spent reviewing all the motions from the 2023 ELCIC Special Convention. With reports and recommendations from four task forces at the special convention, as well as other convention business, there is a significant amount of work between now and the 2025 National Convention. NCC discussed a plan to work through all the motions over the next two years.

Committee of the Whole

NCC spent time meeting in "committee of the whole." Committee of the whole allows for more informal conversation not centered around a specific motion. During this committee of the whole time, council members had a frank and open conversation around their concerns and hopes for the future of the church. This was meant to be the first of many conversations on this topic with the outcome of the conversations enabling a broader scope for where the church is at and providing a connection back to strategic planning for the council.

Next Meeting

The next NCC meeting is scheduled to take place March 1-3, 2024. In light of conversations around our carbon footprint and "that the ELCIC National Office, its staff and programs commit to minimizing greenhouse gas (GHG) emissions that are within their control," (which comes out of the work of the Carbon Neutrality Task Force), NCC approved a motion to hold the March meeting online via zoom.
