## **Opening Prayer**

Meeting Chaplain Rev. Dr. Kimber McNabb led the Opening Prayer.

#### **Business Session One:**

Vice-Chair Bruce Cook called the meeting to order.

## **Recognition of Territory / Welcome**

Vice-Chair Bruce Cook cited the Land Acknowledgement at the beginning of the meeting.

I recently heard someone raise a concern about land acknowledgements and how in many cases they have become nothing more than absent minded genuflections.

Today, I want all of us to take some time to quietly reflect on the land and territory where each of us reside.

Think about time gone by before our days were polluted with noise and exhaust...

Generations ago...

Hear the call of a bald eagle...see it soar

Hear the sound of clean water flowing – effortlessly winding its way across Turtle Island...

Think about the salmon swimming to spawn...

Hear the thundering hooves of the bison roaming...

Feel the heat of the sweat lodge...

Smell the smoke of the smudge...

Hear the song and feel the dance of the Powwow...

See the smiles...

Listen to the stories of the knowledge keepers...

Be one with nature and your surroundings...

Now...imagine...

Your children being taken away to residential school...

Child welfare coming in and scooping children from their communities and families...

People taking your land...

Settlers erasing your traditions, your culture, your identity...

Today we come in truth and we come in reconciliation. Today we all take time, now, to acknowledge the sacred land that we are on. These lands have been the homes of the Indigenous peoples for thousands of years. We thank them for their knowledge and their stewardship of these lands and we thank them for their gracious kindness as we strive to reconcile – as we strive to listen more, to learn more and to do more.

#### Welcome

Vice-Chair Bruce Cook welcomed newly ordained ABT Synod Bishop Trish Schmermund (Ordained on August 24th), and Bishops-elect Ali Tote, SASK Synod (Ordination on October 12th) and Carla Blakley, Eastern Synod (Ordination on September 28th). He also welcomed newly appointed NCC members Rev. Sheldon Gattinger (Rostered, SASK Synod) and Sheryl Dubois (Lay, ABT Synod); and ELCA guest, Kristen Opalinski, Manager for Ecumenical and Inter-Religious Affairs of the Office of the Presiding Bishop of the Evangelical Lutheran Church in America (ELCA). Part of the greeting and welcome was the acknowledgment of Bill Gastmeier's 50th wedding anniversary celebration, and the acknowledgement and heartfelt sympathies in the recent passing away of Sheryl Dubois's son, Jason.

## Report of the National Bishop

Bishop Susan Johnson gave an oral report to NCC in addition to her written report. She mentioned that NCC member Sheryl Dubois is the new lay representative for the ABT Synod replacing Kathleen Jensen while Rev. Sheldon Gattinger is the new rostered representative for the SASK Synod replacing Rev. Dr. Marc Jerry. As an update, NCC member Rev. Dr. Kevin Powell from the ABT Synod had left a vacancy that needs to be filled between now and the next NCC meeting in March.

Bishop Susan acknowledged that the synod bishops (including the bishops-elect) had their Conference of Bishops (COB) meeting. On the other hand, the National Officers met with the National Office staff. She added that NCC hopes to meet everyone in person in March 2025.

Referring to her written report, Bishop Susan mentioned that she was not able to join the solidarity visit to Palestine back in August. With regards to the work within the National Office, Peace Anthony-Idoko, Director for Finance and Administration did wonderful work on our strategic plan by looking at our budget. Information on that was included in the financial report.

Bishop Susan acknowledged and thanked Secretary Linda Grainger for her valuable work on Lutheran Collegiate Bible Institute (LCBI). Linda guided LCBI through their difficult governance and assisted in amending their Act (Legislature of Saskatchewan) under a new governance structure. LCBI will no longer hold their annual general meetings at ELCIC National Conventions in the future. This will be a new reality for Lutherans under LCBI. It's also noteworthy to say that Linda spent more than three years working on this matter.

With regards to ELCIC's support to the Evangelical Lutheran Church in Jordan and the Holy land (ELCJHL), a letter of thanks was received from Bishop Azar. Bishop Susan said that we surpassed our financial goal to assist ELCJHL and that generous gifts from NCC, the Eastern Synod, and various sources were already sent.

#### 10% of Gift Attribution

Bishop Susan mentioned that we made a policy in which ten per cent (10%) of undesignated donations will go to fund the LWF Endowment Fund as part of ELCIC's commitment as a member church. ELCIC has given more per capita than any other member churches, and we would like to acknowledge that. The ELCJHL has opened an endowment fund and no amount is going to that fund yet. Bishop Susan asked NCC if we might consider changing our policy on undesignated funds which currently are to be given to the LWF Endowment Fund and instead, forward that amount to the ELCJHL Endowment Fund. Bishop Susan asked NCC to consider this.

As a background, Jeff Pym sits on the LWF Endowment Board. Bishop Susan can ask on the historical details on what the ELCIC allocation was, and what the fund was for at that time.

## **Appointments**

**NCC-2024-14** That NCC re-appoints Mark Heinen, Synod of ABT, to the Canadian Lutheran World Relief (CLWR) Board for a third term: September 2024 to September 2027. **CARRIED.**

Bishop Jason Zinko gave an oral report to NCC. He mentioned that COB looks forward to working together and alongside with Bishop Susan in doing the work of the church.

#### **ELCIC Pre-Identification Process – for the Election of a Bishop**

Secretary Linda Grainger spoke in addition to the task force's written report on *Pre-Identification Process for the Election of a Bishop*. She informed NCC that together with Stephen Holmes and Bishop Susan, they spoke with synods and put forward matters for NCC's consideration.

**NCC-2024-15** That NCC approves the *Pre-Identification Process for the Election of the National Bishop.* **CARRIED**.

Discussion will be carried over in next day's session.

Vice-Chair Bruce Cook turned the chair over to Bishop Susan.

#### **Communion Practices**

Bishop Susan reminded NCC on the homework that was tasked to them. She enumerated the various documents for review. The documents included were: Alternate Route for Admission to the Roster of Ordained Ministers; Authorized Lay Ministries Guidelines; Authorized Lay Ministries Policy; Reimagining Our Church – Public Ministry in the ELCIC; Reimagining Our Church – Public Ministry in the ELCIC (Reader's Guide); and Theology and Practice of Online Communion.

NCC was encouraged to take some time to read over the documents and reflect on how God is calling us to be a church. NCC was asked to look into those policies that are not being utilized and identify the barriers which can also turn into opportunities.

# Letter from Bishop Larry Kochendorfer and Diaconal Minister Karen Wedman for the ABT Synod Council

NCC reviewed the letter from ABT Synod along with a motion put forward from Finance Committee.

NCC-2024-18 That NCC approves an in-person meeting be held with Synod and National Executives no later than January 25, 2025 to discuss and provide a report by March 2025 National Church Council meeting. The focus of the meeting to be on the following subheadings:

- a. a current Synod and National finances, for the purpose of examining and exploring future sharing of resources and the sustainability of our church;
- b. the use of Mission funds:
- c. the effects of decreasing congregations within the synods;
- d. the current Synodical and National operating structures;
- e. the definition of church membership (understanding the parochial report); and
- f. other warranted items of concern.

#### **Presentation from ELCA Guest**

Kristen Opalinski, Manager for Ecumenical and Inter-Religious Affairs of the Office of the Presiding Bishop for the Evangelical Lutheran Church in America (ELCA) shared some words to NCC. She updated NCC on the work of the Commission for a Renewed Lutheran Church in which the commitment was to dismantle racism. The work of this commission will be forwarded to the 2025 Assembly. Kristen requested NCC for continued prayers and extended her gratitude to Bishop Susan Johnson for her role in the earlier part of this process, and for sharing her gifts of time and wisdom.

Kristen then shared to NCC the various works being done by the ELCA. The current social writing projects of the church were posted on their website: <a href="https://www.elca.org/Faith/Faith-and-Society/Social-Statements">https://www.elca.org/Faith/Faith-and-Society/Social-Statements</a>. She asked NCC to celebrate with them for their church's progress on the diaconate in which an agreement was passed in both Lutheran and Episcopal church bodies. For her final point, Kristen, on behalf of Bishop Eaton, thanked the ELCIC for their continued relationship especially through Churches Beyond Borders. This partnership is a gift to the church with our work in North America, the ELCJHL, and with our Indigenous

brothers and sisters. Kristen also thanked ELCIC Secretary Linda Grainger for her attendance in the ELCA Council Meeting back in April of this year. More prayers especially for peace are requested for the ELCA and the US during these uncertain times, with federal elections coming up in November.

Stephen Holmes provided a brief report on the Audit Committee.

#### **Constitutional Committee**

Secretary Linda Grainger presented the Report of the Constitution Committee. She thanked both Kimber McNabb and Sarah Harrington for their work on the committee. Linda reported that the committee received an amendment from the Chinese Special Conference but it's not ready yet for approval.

NCC-2024-19 That NCC approves the Synod of ABT Constitution and Bylaw amendments as presented. CARRIED.

NCC-2024-20 That NCC approves the MNO Synod Constitution and Bylaw amendments as presented. **CARRIED.** 

#### **Governance Committee**

Heidi Van Schaik, Chair of this committee presented the Report of the Governance Committee.

#### **Nominating Committee**

Bishop Susan mentioned that the Nominating Committee used to be elected at Convention but now members are appointed by NCC. She asked NCC on how they would want to proceed to allow for some input from task forces.

M/S That NCC will appoint members to Nominating Committee via an e-vote. **CARRIED.**

M/S That NCC requests Secretary Linda Grainger to work with National Office staff Carmen Ramirez, to contact the chairs of the task forces on Homophobia, Biphobia, and Transphobia; Racism, White Supremacy, and Issues of Racial Injustice; and Ableism, to seek names for the Nominating Committee.



## National Church Council Meeting Highlights

The ELCIC's National Church Council (NCC) met September 12 & 13, 2024 for their fall meeting. The meeting was a combination of in-person and hybrid. With three new synod bishops elected at Synod Conventions across the church earlier this year, the Conference of Bishops decided to have their first meeting in-person. The officers of the church also met in-person.

Rev. Dr. Kimber McNabb led NCC in prayer at the beginning and end of each session. Each of her prayers included a prayer pose as an intentional way of holding space and being more engaged in the prayers.

## Discernment and pre-identification process for National Bishop

At the 2025 ELCIC National Convention, taking place July 10–13, 2025 at the University of Manitoba in Winnipeg, Manitoba, delegates will elect a new National Bishop. Following 18 years of service, current National Bishop Susan Johnson has announced she will not be letting her name stand for re-election.

In anticipation of this, NCC has reviewed and approved a process to assist the church in discerning the skills, gifts and call of potential candidates. While our current bylaws will ensure that the first ballot for bishop is still an ecclesiastical ballot (all rostered pastors within the ELCIC are eligible for nomination on the first ballot), this discernment process allows for an intentional time of inviting congregations and communities to engage in prayer and conversation about the role of the National Bishop, consider a "job description" for the call to lead the church, and allow names to come forward through a pre-identification process.

ELCIC members will start to see this roll out very shortly with a *Discernment Study Guide* and accompanying job description. Starting in January, ELCIC members will be complete a pre-identification process for those candidates they wish to put forward. This process will be open until March 31, 2025. After that time, a task force will share out more information about those pre-identified candidates via biographical information and video interviews. The *ELCIC Bylaws* will still be the guiding document to the election process when delegates meet in convention in July 2025. Detailed information will be posted to the ELCIC website in October.

## Review of documents around lay communion

NCC reviewed documents pertaining to Communion Practices in the ELCIC, including: Alternate Route for Admission to the Roster of Ordained Ministers; Authorized Lay Ministries Guidelines; Authorized Lay Ministries Policy; Reimagining Our Church – Public Ministry in the ELCIC; Reimagining Our Church – Public Ministry in the ELCIC (Reader's Guide); and Theology and Practice of Online Communion. NCC was asked to look those policies that are not being utilized more fully and identify any barriers to engaging in these policies and procedures.

## **NEW NAME - Ability and Inclusion Task Force**

At the September 2024 NCC meeting, a motion was put forward by the Task Force on Addressing Ableism and Inclusivity to change their name to the Ability and Inclusion task force. It was felt that the word ability is a more universal term, with the focus of the committee more on lilting up abilities that people have, instead of highlighting disabilities.

## National, Synod Officers to meet in January 2025

NCC members reviewed and discussed a motion brought forward from the Finance committee to hold a National, Synodical Officers consultation in January 2025, with a report provided to the March 2025 NCC meeting. Agenda topics for the meeting include: current National, Synod finances, the use of ELCIC Mission Funds, effects of decreasing congregations within the synods, current National, Synod operating structures, definition of church membership and other items of mutual concern.

## **Next Meeting**

The next NCC meeting is scheduled to take place March 7-9, 2025. This meeting will take place in-person.
